Important

Passengers should report at terminal One Hour (1 Hour) before departure time. Terminal gate close 30 minutes before scheduled departure.

Terms and Conditions:

- 1) Current Booking closes 1 hour before ferry departure.
- 2) Boarding / Check-In closes 30 minutes before Ferry Departure. No show of passengers / Vehicle for boarding will be treated as

automatic cancellation and no refund shall be issued. Tickets of Passengers/vehicles reporting after check-in time closes shall be

automatically canceled and no refund shall be issued.

3) Passengers are requested to wear the wristbands issued from ticket counters throughout the journey. The absence of wristband shall

attract a penalty of Rs. 500/-.

- 4) Priority will be given to emergency services during Check-in & Check Out.
- 5) Truck Drivers are requested to ensure that they have valid driving license and that the truck is in good physical condition with valid

registration, insurance and fitness certificate. Truck drivers are requested to produce Bilti / LR & Challan at Ticket counter. Boarding the

ferry can be denied in the absence of any of the above documents.

- 6) Smoking / Spitting / Chewing Tobacco on the Ferry and within Terminal premises is prohibited and punishable by law. Penalty Rs.
- 2,500/- shall be charged from defaulters.
- 7) Carrying and Consumption of alcohol on the Ferry and within Terminal premises is strictly prohibited and is a punishable offense.
- 8) All passengers are requested to cooperate for luggage/vehicle scanning.
- 9) Misconduct with Security staff, Terminal Staff, Ferry Crew, and Fellow passengers is punishable by law.
- 10) Damage to the Ferry / Terminal property is punishable by law.
- 11) The Ferry Operator is indemnified from any loss to the Owners belongings.
- 12) Parking & Boarding at Owners risk.
- 13) Right of Admission Reserved.
- 14) Carrying and consumption of banned substances is strictly prohibited onboard the ferry for which you would be arrested and severely prosecuted by police. Ferry Operators Indigo Seaways Private Limited sternly warn against carrying of such substances.

Damage to any property of this Ferry viz. the Doors, Seats, TV, AC, life jackets etc are punishable and defaulters shall be charged accordingly. If the penalty charges are not paid suitable actions shall be initiated and defaulters shall not be allowed to deboard the Ferry/leave terminal premises.
